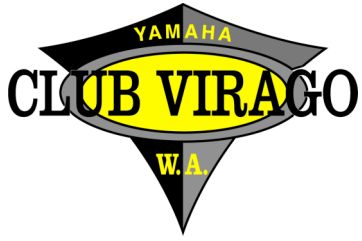

## CLUB VIRAGO WA (INC) RIDE RULES

1. A "Ride Leader" and "Tail End Charlie" will be nominated for all official Club rides.
2. Tail End Charlie will carry the Club's tool kit and first aid kit on all official Club rides.
3. Riding positions shall be staggered behind the Ride Leader and a safe riding distance of a least a two (2) second interval shall be observed between riders.
4. Keep an eye out for the rider behind. If she/he drops back, do the same so that by the time all riders in front have slowed down, the message will reach the Ride Leader that there may be trouble somewhere down the line.
5. The rider immediately behind the Ride Leader will, **at his discretion** only where safe to do so, wait on corners out of the way of traffic with the appropriate turn signal flashing to indicate the route following riders are to take.
6. Passing on the left is strictly prohibited.
7. Members shall ride responsibly and observe all State road laws, speed limits and appropriate road craft for the riding conditions.
8. Road use will not be monopolised to the detriment of other road users.
9. Riders wishing to deviate or quit the ride midway must notify the Ride Leader or Tail End Charlie before leaving.
10. Any rider who overtakes the Ride Leader will be deemed to have left the ride.
11. A Club Register will be maintained by the organisers (or the Tour Master) for each official Club ride with details of:
  - Rider.
  - Pillion.
  - Next of Kin and contact telephone number.
  - Bike Registration number.
  - Your signature accepting Ride Waiver (See Over).

## **Agreement to Participate in Motorcycling Event and or Activity.**

I hereby agree with Club Virago W.A. Inc. (hereinafter collectively called “the organiser”) that I participate in the motorcycle activity solely on the terms and conditions set out in this document.

## **Acknowledgment of Risks, Dangers and Obligations**

1. I acknowledge:
  - a) Motorcycle sport is a dangerous activity with many risks and dangers;
  - b) I may be injured, physically and or mentally, including serious long term injury and death;
  - c) My machinery, equipment and other property may be damaged, lost or destroyed;
  - d) I should participate in the meeting only if I have sufficient skill and understanding in motorcycling to participate safely;
  - e) Other participants may ride dangerously or with a lack of skill, which may cause me harm;
  - f) Road, weather and event conditions may be hazardous without warning or predictability;
  - g) The organisers may be required to make decisions under pressure of time or events and cannot be responsible for my safety and the actions of others;
  - h) There may not be any or adequate facilities for medical treatment and transport to medical facilities;
  - i) I am obligated to myself and to others to participate safely, skilfully and within the rules of the event.

## **Agreement with Organisers**

2. In consideration of my acceptance as a participant in the event I AGREE with the organisers that:
  - a) I participate in the event at my sole risk and responsibility and I release from any duty of care that they may owe to me in respect of the event but for this agreement;
  - b) I accept the venue and other activity / meeting conditions as they stand with all defects hidden and exposed;
  - c) I waive any rights at law or by virtue (including for negligence) which but for this clause I have to sue or make claim or demand against organisers in respect of any injury, illness or death, or damage to any property, arising out of the any event;
  - d) I indemnify and hold harmless the organisers against any and all costs, expenses, losses and damage suffered and incurred by the organisers arising out of any actions or claims against the organisers arising out of any injury to any person caused or contributed to by any act or omission on my part;
  - e) I indemnify and hold harmless the organisers against any and all costs, expenses, losses and damage suffered and incurred by the organisers which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my property whether caused by the organisers negligence, breach of contract or in any other manner whatsoever.

**This document is to bind my guardians, attorneys, successors and executors.**
